## Agenda items:

- a. Call Meeting to Order (Bill Braun) 11:35am
- b. Technical Director voted in Chris Sherman as Technical Director (replacing Jay Stahl) –
  unanimous vote by four elected officers, and unanimous agreement by all attending.
   Welcome to Chris! Thank you to Jay for your many years of excellent service to the Chapter!
- c. Discuss Membership Forms (Ed) Discussion about A) renewal percentages/process and membership counts, B) new member process. A) Renewals Ed provided a summary of recent renewal cycle: three mailings sent (Nov, Dec, Jan) overall, 80 members expired, 72 renewed (90%). 6 of these 72 used the National site to renew (4 of which were renewing their national membership at the same time), 66 renewed by the paper form (mailed to Ed). Decision to keep renewal process the same, as it is successful and yields good results. The (current) paper renewal form allows for multi-year discounts on chapter membership, the National website renewal process does not allow for this. Members can still renew on the National site if they wish. Membership counts mid-year from 2013-2022 were 165, 164, 158, 156, 160, 169, 152, 134, 131, 141. 2023 YTD 152. B) New Member Process Since new members must be a National Member in order to join the chapter, using the National website to join National and our Chapter is the best process. This eliminates the issue of the person trying to join the chapter when they are not a National member yet. It is recognized that paper membership

forms to join are still needed, however, such as handing out at shows/events. We will still use these in these limited situations. On our website, we will create an "instruction page" to tell prospective members how to join on the National site (both for National and our Chapter). This sheet can also be printed to be used at car shows, judging meets, etc. to use as a handout for new members. We will not put a "join" form on the website. Complimentary memberships will be provided under certain conditions, such as National members who register for our judging meet who are not IL Chapter members. PO Box will be eliminated, as it is no longer needed.

- d. Discuss Registration Fee for (future) Pontiac Chapter Meet (Scott) Scott provided a table of the registration, judging, etc. fees for many 2023 events. Our fee is high, will plan to lower it in the future, and also provide reduced fees if someone is just coming to the event to judge. This year we will provide the free pizza party and perhaps some other gifts to compensate for the higher registration fee (perhaps lower the holiday party price significantly or other reductions; considered gifts also, such as coffee mug). Discussed a minimum threshold for operating funds, to serve cash flow needs and to have a reserve.

  - Discuss Pontiac Judging Meet Discussion and preparation for the upcoming judging meet. Have 7 flight judge cars, 2 Concours judge cars, 1 crossed-flag display, several sportsman. Still receiving registrations, big turn out! Set up will be on Friday, judged cars are to be there by 2pm.
  - Discussed Meadowdale event. The MIRPA event is still being held, but it was decided that IL NCRS will not have a judging meet there this year. Had two cars registered – one member (an officer) said it was fine to not have his car judged there. Gary will contact the other car owner, will try to make an accommodation for judging his car (such as a one-car judging school/meet or MCACN or ?).
    - **Post Meeting Update 5/9/23:** The IL NCRS Chapter WILL participate in the Meadowdale event for 2023 as planned, as we committed to participate. A majority of officer votes were obtained to reverse the 5/3 meeting decision.
